If you cancel a booking 90 days prior to your function, your deposit will be refunded in full. After that date your deposit is non refundable.

### Cancellation Policy.

The following charges will apply upon cancellation of a function;  
Within 14 days of function; full payment of total estimated cost.\*  
Within 15-30 days of function; 75 % of estimated cost  
Within 31-59 days of function; 50 % of estimated cost.

\*Estimated cost is the estimated amount detailed on the function booking form.

The total balance is payable two weeks prior to your function (unless otherwise arranged and confirmed in writing by Island Bar Restaurant). If full payment is not received, your booking will be cancelled and the deposit non refundable.

The menu selection for your party needs to be pre-ordered, the table plan and the information for name cards needs to be given at least 2 weeks prior to your function.

The organisers of the function are responsible for their guests and their conduct. We reserve the right to remove intoxicated guests from our premises. Island Bar Restaurant also reserves the right to call short a function if guests do not act responsibly. Any deliberate damages and breakages, during the event will be billed to the organiser.

We reserve the right not to serve alcohol to any customer who appears to be under the age of 18 and is not carrying valid identification.

CCTV is in full operation on the premises.
